

Pasco CTST – April 24, 2024

Meeting started at 1:34 pm

I. Welcome and Introductions were made.

II. Meeting Dedication

Tina Russo (Pasco MPO): Tina dedicated the meeting to a pedestrian who died on October 30th, 2023. The fatal crash was not too far from US 19, a little bit north of SR 54. She was an older lady, around 8:00 pm and dark outside; not far from her home. It was a hit and run crash on a neighborhood street.

III. Minutes Approved

IV. Old Business

- 1. US 19 and Bay Boulevard No update.
- 2. US 301 and Chancey Road The construction is well underway. If there is any engagement going on, it would be a good time with all the focus on work zone safety.
- 3. Daughtery Road and US 301 No update.
- 4. Seven Springs Boulevard No update.

Tina Russo (Pasco MPO): Pasco MPO is hopefully a few months away from signing their safety action plan agreement with the Federal Highway Administration. Once that happens, they will move forward with a twoyear safety action plan that lets them dive into a lot of data. Pasco County received a significant amount of information on crash data from their long-range transportation plan that they will be able to use to move forward with some projects.

Tim Russo (Pasco MPO): Pasco MPO did a Road Safety Audit for Geiger Road, and they are in the process of working on some countermeasures and improvements on Geiger Road. There is a meeting tomorrow on this.

V. New Business

Education

Tina Russo (Pasco MPO): Kasey Cursey and the Pasco MPO recently did some helmet fitting programs, including one for crossing guards and one for PE teachers for Pasco County. Pasco County Schools did a video on it and they're getting ready to launch a three-minute bike safety video that they are going to use in homeroom. The poster contest that Safe Kids did had a great turnout. Pasco MPO may use some of the posters for public safety announcements and on the Tampa Bay Traffic Safety webpage.

Kasey Cursey (EXP): Kasey and Tina had a chance to get in some communities. They did the Dade City helmet fitting on March 25th and they fitted 47 helmets. They also did fittings at Zephyrhills's Mobility Workshop. They are also starting a conversation to get into Withlacoochee.



Brentin Mosher (CUTR): CUTR is running a work zone awareness geofencing campaign. Last week was Work Zone Awareness Week and they were trying to make people aware of the laws and safety behaviors as it pertains to work zones. CUTR is working on the contract for the Enhanced Law Enforcement Engagement (ELEE) program, Phase Three.

Pastor Jen Kerouac (Shady Hills Mission Chapel): Pastor Jen is willing to assist with helmet fittings in Shady Hills. It is a bit of a unique situation with not having sidewalks. Jen met, through the Stand Down, a gentleman who wants to help fix bikes and wheelchairs. He is going back to Vermont, but that could be another layer of it in the future, making sure that bikes are in good working order.

Enforcement

Engineering

Tina Russo (Pasco MPO): Tina discussed the Long-Range Transportation Plan. They are on the second round of workshops and are on the needs list, looking at projects and then they want to make sure with this needs list, the transit and bike ped portion gets done with it also. They are also making sure that their roads are complete streets, meaning that every roadway project will have sidewalks, multi-use paths, and bike lanes on it as well. It is not just about bike/ped, but it's about everything being multi-modal as well.

Crash Statistics

Lori Palaio (JMT): She stated from January 1st to February 9th, 2024, there have been 10 fatal crashes which include three left turns, two run off the roads, two head on, one other, one pedestrian, and one right angle fatal crash.

The three left turn fatal crashes occurred at:

- 1. US 19 and Louis Avenue at the t-intersection in day, clear, and dry conditions. It was a motorcycle fatality.
- 2. US 301 and US 98 at the t-intersection in dark-lighted, cloudy, and wet conditions.
- 3. SR 56 and Wiregrass Ranch Boulevard at the four-way intersection in day, clear, and dry conditions. It was a motorcycle fatality.

The two run off the road fatal crashes occurred at:

- 1. SR 54 and Marathon Road, not at the intersection, in day, clear, and dry conditions. The vehicle hit a tree.
- 2. US 41 and Twin Oaks Road, not at the intersection in day, clear, and dry conditions. The vehicle hit a fence.

The two head on fatal crashes occurred at:

1. Paul S. Buchman Highway and Pattie Road, not at the intersection, in dark not-lighted, clear, and dry conditions. It was a motorcycle fatality.



2. Bellamy Brothers Boulevard and Miller Road, not at the intersection in dark not-lighted, clear, and dry conditions.

The other fatal crash occurred at Bellamy Brothers Boulevard and Paloma Lane, not at the intersection, in dark not-lighted, clear, and dry conditions. It was a motorcycle fatality. The pedestrian fatal crash occurred at Old County Road 54 and Wood Trail Boulevard, at the four-way intersection in dark not-lighted, clear, and dry conditions. The right angle fatal crash occurred at Coats Road and Chancey Road, at the four-way intersection in day, clear, and dry conditions. Forty percent of the fatal crashes have been motorcycle fatal crashes. There were 10 fatal crashes from January 1st to February 9th, 2024. Same period in 2023 there were also 10 fatal crashes, so no change same period.

Tina Russo (Pasco MPO): The two fatal crashes on Bellamy Brothers Boulevard were a day apart, they were both at nighttime, and one was motorcycle related. The MPO has elevated Bellamy Brothers Boulevard on their list of priority projects to the top ten in hope to get funding for the safety improvements. The two recent fatal crashes were on the southern portion of Bellamy Brothers Boulevard. Most of the Bellamy Brothers Boulevard fatal crashes are on the northern portion. Discussion followed on if motorcyclists are wearing helmets as well as if vehicle users are wearing seatbelts.

VI. Calendar Updates / Activity Reports

Tina Russo (Pasco MPO): Pasco MPO did the Battle of the Belts for Safe Kids where they went to several schools and did some counts on seat belt use with the high school students. They are doing both the pre and post surveys. Many vehicles had tinted windows, so it was hard to see if kids were wearing seatbelts. Discussion followed. The bigger conversation is the vaping situation with the middle school and high school students. Vaping becomes an issue with impaired driving and distracted driving.

Eric Henry (FDOT): Next month is motorcycle safety awareness month. There has been an upward ticking trend in motorcycle fatalities districtwide. FDOT is trying to get a lot of yard signs, tip cards, motorcycle focused events, etc.

VIII. Highway Safety Improvement Program (HSIP) Updates

Melissa Shepherd (JMT): The HSIP portal is up and running for applications. Tomorrow at the Geiger Road meeting, countermeasures for HSIP funding may be discussed. If anyone has any HSIP questions, let Melissa know.

IX. Open Forum/Announcements

Melissa Shepherd (JMT): The Safe Streets 4 All (SS4A) grant is up and running. The first deadline ended in April. There are two deadlines left. May 16th is the second deadline for the planning and demonstration grants and the sole deadline for the implementation grant. and demonstration grants and the grant cycle closes until 2025. There is plenty of funding still available. If you have questions on how to submit the action plan or need examples, please let her know. There is a great deal of resources on the Safe Streets 4 All (SS4A) grants website.

Tina Russo (Pasco MPO): For Pasco MPO's safety action plan, they are in the last stages of finishing up their agreement with Federal Highway Administration for SS4A. Gulf Safe Street Summit will probably be happening in October in Hillsborough with the Pedestrian Bicycle Coalition group.

Shannon Kennedy-Smith (Alliance for Healthy Communities): The Alliance for Healthy Communities is doing a free event on May 30th at the Main Event in Wesley Chapel from 5:00 pm to 9:00 pm. It's free for kids, guardians, or parents. They are doing a number of those events throughout Pasco County. They did one last month at Spin Nations. They are going to have one in Wesley Chapel and the next two events are going to be on the east side. Shannon is happy to partner with anybody if they want to do helmet fittings or anything else.

Pastor Jen Kerouac (Shady Hills Mission Chapel): A development is going in on Shady Hills Road. There are issues on SR 52 and Shady Hills Road. The light is running very quickly and there have been some crashes. A lady was recently rear ended by a dump truck and the dump truck left. A lot of the issues could be fixed by the timing of the light on SR 52 and Shady Hills Road. It is backing up past Classical Prep to the north. Venkat Vattikuti said, on Shady Hills Road, the contractor had some issues a couple of days back. He believes it was resolved, but he will investigate Pastor Jen's request to see if there is anything he could assist until the complete widening project is done. Discussion followed.
