### **MEETING MINUTES - JUNE 2024**



#### Pasco CTST - June 26, 2024

Meeting started at 1:33 pm

I. Welcome and Introductions were made.

#### II. Meeting Dedication

Tina Russo (Pasco MPO): Tina dedicated the meeting to a pedestrian fatality. Last month a pedestrian on SR 52 walked in front of a motorcycle and then was hit by a Ford F-150.

#### III. Minutes Approved

May minutes were approved.

Tina Russo (Pasco MPO): John Koors will be leaving the MPO.

#### IV. Old Business

- 1. **US 19 and Bay Boulevard** Eric Henry did not hear back from Joellen.
- 2. US 301 and Chancey Road Improvements are being made. Construction is almost complete. This will stay on the problem locations sheet until construction is finished.
- 3. Daughtery Road and US 301 Pasco County can do the timing change if FDOT allows it. Tina Russo will send Eric Henry more information. Eric Henry will get with Traffic Operations. Amy Davis stated that the signal will have to change from a three-section head to a five-section head.
- 4. US 19 and Camry Drive Tina discussed moving the crosswalk closer as there are sight distance issues. Discussion followed on possible signage options. Tina Russo will look to see different alternatives available.
- 5. SR 52 from east of Colony Road to Moon Lake Road Eric Henry stated that they are looking to do access management at this location. FDOT is looking at preferred alternatives to see if they can put a signal somewhere and where the signal would be.
- **6. Seven Springs Boulevard** This location is a Safety Action Plan item. There are a lot of countermeasures for this location that they will need funding for.

Tina Russo (Pasco MPO): Tina discussed Geiger Road improvements. Public Works is in the process of reclamation. The County will redo the road. They are thinking about installing a safety edge. Next steps will include striping, signage, and RPM improvements. After that, they will look at sidewalk improvements. The County approved a resurfacing contract in the Capital Improvement Program (CIP). There are some right-of-way issues, so after everything else is done, a right-of-way survey will be completed.

William (Bill) Poe (City of Zephryhills): Bill discussed partnering financially to install the sidewalk. Discussion followed.

Jonathan Rose (Zephyrhills PD): Geiger Road and Gall Boulevard only have one sign. Jonathan Rose will get with the lieutenant or chief to discuss getting another sign in.

Mayor Melonie Monson discussed getting signs that stated, "No Trucks or you will be Ticketed." She stated that it has worked in the past, as well as enforcement presence. The mayor discussed adding a midblock as well as having the speed reduced on Geiger Road. Amy Davis, of Pasco County, discussed that Geiger Road could have truck route with arrows. Melissa Shepherd, of JMT, discussed providing feedback to Google Maps so that trucks are sent an alternative route. Discussion followed on an app that trucks use when traveling.

Todd Vandeberg (City of Zephyrhills): Todd discussed the mobility plan west of Zephyr Park at Coral Street. He stated he would send Tina the information.

Randy Stovall (Pasco BPAC): He suggested to the City partner with the County, on Wire Road, to get the improvements going. There is no sidewalk and this is very unsafe for children. Tina Russo stated that Wire Road is on the CIP list to do a multi-use path for fiscal year (FY) 2027. The concern on Wire Road starts from Daughtery Road south and ends at SR 54. About a half a mile of sidewalk is needed. Discussion followed regarding sidewalk gaps. The City is willing to assist with funding. Amy Davis, of Pasco County, said the County is pushing Rectangular Rapid Flashing Beacons (RRFBs) in school zones. Bill stated that he is willing to give funds for sidewalk improvements. Bill also suggested possibly adding RPM's. Amy Davis suggested adding traverse lines on the curves. Wire Road will be added to the Challenging Locations sheet.

#### V. New Business

#### Education

Tina Russo (Pasco MPO): There will be a back to school helmet fitting on July 27<sup>th</sup> at UF in Dade City at One Stop.

#### Enforcement

Brentin Mosher (CUTR): The Enhanced Law Enforcement Engagement (ELEE) will kick off on July 1<sup>st</sup>. Law enforcement agencies will conduct targeted enforcement on state roads. This is a nine-month enforcement program. Zephryhills Police Department will be participating for the first time.

#### Engineering

None.

#### Crash Statistics

Lori Palaio (JMT): From January 1st to April 9th, 2024, there have been 29 fatal crashes. At the last CTST from January 1st to March 5th there were 17 fatal crashes. The 12 new fatal crashes include four pedestrians, three others, one bicycle, and one head on. Five occurred at night and three were motorcycle related.

For the pedestrian fatal crashes:

- One pedestrian fatal crash was at Otis Allen Road and Sheppard Lane, not at the intersection in dark not-lighted, clear, and dry conditions.
- The second pedestrian fatal crash was at US 301 and Clinton Avenue, not at the intersection in dark not-lighted, clear, and dry conditions.
- The third pedestrian fatal crash was at Green Slope Drive and Oak Run Circle, at the t-intersection
  in dark not-lighted, clear, and dry conditions. The fourth fatal crash was the same fatal crash as the
  one at Green Slope Drive and Oak Run Circle. The same people were involved, but two different
  officers reported it. So, there were only three new pedestrian fatal crashes, instead of four, since
  one was double counted.
- There are currently 29 fatal crashes through April 9<sup>th</sup>, 2024. Same period in 2023 there were 30 fatal crashes, so Pasco County is down by one fatal crash.

Jim Reiser (LEL): Jim Reiser explained the Memorandum of Understanding (MOU) and the difficulties of obtaining 60-day access.

#### VI. Calendar Updates / Activity Reports

Brian Michaels (Pasco BPAC): Brian gave a presentation on Turning Vehicles Stop for Pedestrians (R10-15a) signs. October is National Pedestrian Safety Month. The goal is to bring awareness to sign changes throughout the tri-county Tampa Bay area at signalized intersections with a target date of October 1st, 2024, which is Pedestrian Safety Month. The goals are to promote the newer R10-15a Stop for Pedestrians through driver education; utilize all-media including radio, television, newspaper, and other media TV channels; utilize electronic message boards with Stop for Pedestrian messages; engage all law enforcement, local, county, and state to issue warnings or tickets; and lastly Florida's Vision Zero initiative to eliminate all transportation-related fatalities and serious injuries – FDOT has formally established a target of zero transportation-related fatalities and serious injuries when measuring progress toward their vision. Discussion followed.

Jim Reiser (LEL): Jim Discussed the High Visibility Enforcement (HVE) grant for pedestrian and bicycle enforcement. The HVE grant will run through May. Zephryhills received the grant.
