#### **MEETING MINUTES - AUGUST 2024**



#### Pasco CTST - August 28, 2024

Meeting started at 1:30 pm

I. Welcome and Introductions were made.

#### II. Meeting Dedication

Tina Russo (Pasco MPO): Tina dedicated the meeting to a fatality that occurred on August 16<sup>th</sup>. There was a 75-year-old New Port Richey man who was traveling southbound on Little Road. Vehicle two was driven by a 45-year-old man who was traveling northbound on Little Road at the intersection of Heritage Lakes Boulevard. Vehicle one turned into the path of vehicle two. Driver one and two suffered minor injuries, while the passenger traveling in vehicle one was a 73-year-old New Port Richey woman that was transported to the hospital and later expired from her injuries. Since that crash, there was another fatality at the exact same location and was a similar type of crash. There was a rapid response from traffic operations.

Amy Davis (Pasco County): The neighborhood at Little Road and Heritage Lakes Boulevard liked having the permissive left flashing yellow arrow, but the community decided it wasn't worth it. It is no longer a protected permissive left flashing yellow arrow. Now the phase goes straight to red.

Tina Russo (Pasco MPO): It is a 55 plus older community that the left turn goes into on Little Road and Heritage Lakes Boulevard. Based on crash studies, aging drivers have a harder time with permissive left turns. But the fatality that occurred a couple days ago was not an older person, it was a 35-year-old person that made that left turn.

#### III. Minutes Approved

July minutes were approved.

#### IV. Old Business

- 1. US 19 and Bay Boulevard No update.
- US 301 and Chancey Road Tina Russo stated that someone asked about the
  westbound movement at Chancey Road. The left turn lane should be a right turn and
  straight through lane. Tina will verify what the question was and then pass it on to FDOT
  and the County.
- 3. Daughtery Road and US 301 Discussion occurred on access management. The traffic flows from the Golden Corral to the south, and vehicles cut through the parking lot. The intersection crosswalks are offset as well. Tina Russo will look at the crashes.
- **4. US 19 and Camry Drive –** *This can be removed from the problem locations sheet.*
- 5. SR 52 from east of Colony Road to Moon Lake Road No update.
- **6. Seven Springs Boulevard –** *This can be removed from the problem locations sheet.*
- 7. Wire Road There is a CIP project for the sidewalk with the County. Tina Russo stated that once the County moves forward with what needs to be done on Wire Road, they will start looking at adding a midblock. Randy Stovall, from Pasco BPAC, stated that Hercules Park near a school is scheduled for reopening in December. They expect that would drive

additional traffic if there were a midblock. There is going to be another apartment complex going in on the corner of Wire Road and Pretty Pond Road. There is also another apartment complex on the opposite corner of Pretty Pond Road and Wire Road. That is another reason why a midblock must be installed. Amy Davis, Pasco County, stated that they put flashers for the school zone area in anticipation that there will be a midblock at Dairy Road. Amy Davis stated that they were asked to reevaluate the school zone at Henry Drive as well, but it is not in their jurisdiction.

The meeting dedication: Little Road at Heritage Lakes Boulevard will be added to the problem locations sheet.

#### V. New Business

#### Education

Renisa Martinez (John's Hopkins): Battle of the Belts is a teen safe driving program that they have had for the past 15 years in Pasco County. September 3<sup>rd</sup>, Battle of the Belts will be honoring Hudson High, who had the most improved seat belt usage with a \$500 check. There will be a child passenger safety event on September 21<sup>st</sup>. This is a wonderful event for families or caregivers who need car seats, as they will be for free with installation included. The local Rotary Club will be donating about 20 car seats. It will start at 10:00 am and will be held at Fire Station 13. Recently, John's Hopkins attended the Kids in Motion conference, which is one of the largest conferences on child passenger safety. One thing they took away from the conference is the tribal and native communities here. Renisa received a contact form Mike Zinn and Goerge Edmiston, so she will be reaching out on how she can facilitate and operate events for tribal and native communities.

Tina Russo (Pasco MPO): Tina thanked Renisa Martinez and Sheila Rainey for providing helmets for Dade City. There has been a shortage of helmets, and both Renisa and Sheila were very helpful. Discussion followed.

Sheila Rainey (John's Hopkins): Walk to School Day is coming up on October 9th. Sheila is in the process of getting email lists for principals and assistant principals and she will send a flyer to them to encourage them to participate in Walk to School Day.

Brian Michaels (Pasco MPO): October is Pedestrian Safety Month. October 1st will be Project Red Light, which includes education and enforcement on the new R10-15a signs which are Stop for Pedestrian signs. Pasco MPO was fortunate to have Pasco County utilities include the information in their newsletter that will go out to every billable customer in Pasco County. There will be an article about stopping for pedestrians. They also have the support from their tax collector's office, which includes all five of their offices. They will do a slideshow presentation that runs throughout the day of these various signs that Brian created for Pedestrian Safety Month. They are also sharing information with Pasco, Hillsborough, the City of Tampa, and the City of St. Petersburg. FDOT is working on updating a PSA that they made in 2019 with the correct signage. They are waiting for FDOT to see what digital materials they will supply. Brian will be at Hillsborough County BPAC tonight to do a presentation.

Brentin Mosher (CUTR): Brentin discussed the new midblock pedestrian signal at US 19 and Buena Vista Lane or Bartelt Road. CUTR is doing a survey monkey, as well as doing social media promotions and geofencing for the midblock pedestrian signals. CUTR is also doing on street education for the signal and tip card delivery to local businesses. There is a mail plan to have a robust way to reach as many people as possible with information about these crosswalks and how they are slightly different from a regular traffic signal. Discussion followed.

#### Enforcement

Jim Reiser (LEL): Right now, they are doing Drive Sober Get Pulled Over that runs through Labor Day weekend. Pasco County is getting ready to do a saturation patrol on Saturday night. Port Richey Police Department will have a briefing there. It will include New Port Richey, Port Richey, and possibly Pasco County Sheriff's Office. Pasco County Sheriff's Office is looking for some training materials to get their deputies trained on basic field sobriety exercises. Their goal is to train 80 of their field training officers. The pedestrian and bicycle enforcement grants should be coming online with Port Richey and New Port Richey shortly. Zephyrhills is in the process of getting their grants approved. Operation Southern Slowdown was a success in July. There was a big multi-jurisdictional operation on US 19 and the numbers were successful.

George Edmiston (Benesch): Last Wednesday, August 21st, was one of the biggest Enhanced Law Enforcement Engagement (ELEE) operations so far in three years of the program. They put a US 19 detail together to encompass four counties. They went from the Skyway Bridge all the way up to the Levy County Line. There were 13 agencies involved, and close to 100 officers involved for eight hours on US 19 to address a lot of crashes that have been causing serious bodily injury and death. As a result of the operation, there were 811 traffic stops, 520 citations, 353 warnings, three DUI arrests, 10 drug arrests, 59 move over violations, 242 speeding violations, and 12 drivers license for driving on a suspended or no valid drivers' license. George is planning an operation through Pasco County in the next month or so, which will encompass US 301 from the Manatee Line to Sumter County Line.

#### Engineering

Tina Russo (Pasco MPO): Pasco MPO will go to their committees at the end of September and the MPO board on October 3<sup>rd</sup> to sign their agreement with Federal Highways and USDOT for their Safety Action Plan. Tina has been interviewing consultants today and tomorrow about who will do that Safety Action Plan. It will be a good year and a half process along the way.

#### Crash Statistics

Lori Palaio (JMT): Lori Palaio discussed the fatal crash map. From January 1st to June 12th, 2024, there have been 46 fatal crashes. At the last CTST from January 1st to May 5th, 2024, there were 31 fatal crashes. The 15 new fatal crashes include one rollover, one bicycle, one rear end, two sideswipe, three right angle, four pedestrian, and three left turn fatal crashes. Seven of the 15 fatal crashes were motorcycle related, eight of the 15 fatal crashes were at an intersection, ten of the 15 fatal crashes were in dark conditions, and one of the 15 were drug related. For the four new pedestrian fatal crashes, they were at SR 54 and Allen Road, Little Road and Villa Entrada, SR 52 and Colony Road, and Wells Road and Boyette

Road. There have been 46 fatal crashes since June 12<sup>th</sup>. Same period in 2023 there have been 45 fatal crashes. Pasco County is up by one fatal crash same period. Motorcycles represent the highest fatality type by mode of travel.

#### VI. Calendar Updates / Activity Reports

Tina Russo (Pasco MPO): October 9<sup>th</sup> is the Gulf Coast Safe Street Summit. It is form 1:00 pm to 5:00 pm and it is in the Port Tampa Bay Cruise Terminal. The pedestrian and bicycle coalition are meeting the day before this on October 8<sup>th</sup>.

Lori Palaio (JMT): October is also pedestrian month. Lori asked the group if there are any other events going on for pedestrian month.

Lori Palaio (JMT): JMT/FDOT received a request from New Port Richey from Samantha Hamilton, and she gave a great presentation explaining the RRFB she would like installed. The application is currently under review. If anyone needs assistance using the form to request items, please let Lori or Melissa Shepherd from JMT know and they can walk you through how to do it. The funding is limited, so it's on a first come first serve basis.

Lori Palaio (JMT): The CTST Mega Meeting is on September 12<sup>th</sup> at 9:00 am. Registration is now open, so please check your email and we would like as much attendance as possible. There will be no Pasco CTST meeting in September, it will only be the CTST Mega Meeting. It will be held at the AAA facility on Henderson Road.
