MEETING MINUTES - DECEMBER 2024

Pasco CTST - December 11, 2024

Meeting started at 10:02am

I. Welcome and Introductions were made.

II. Meeting Dedication

Tina Russo (Pasco MPO): Tina Russo is hoping to have a deeper conversation about motorcycle fatalities later in the meeting, so that will be the meeting dedication. We do not get to see the ones that we save every day.

III. Minutes Approved

October minutes were approved.

IV. Old Business

- US 19 and Bay Boulevard Eric Henry clarified some of the confusion with traffic operations, whether we were looking at this intersection or the one further south on Gulf Drive. Eric clarified the location was at US 19 and Bay Boulevard.
- 2. US 301 and Chancey Road Eric Henry stated that construction completed on December 4th. They are still pending some final reviews before everything is submitted on FDOT's side.
- Daughtery Road and US 301 There is a meeting in Zephyrhills this morning. No further update.
- **4. SR 52 from east of Colony Road to Moon Lake Road** SR 52 is resurfacing and there will be some access management changes. Eric Henry will check back with the project manager to see if there have been any new updates.
- 5. SR 56 from Bruce B Downs Boulevard to US 301 Jeffrey Moncalian of Pasco County stated that they had something they were working on to get street lighting on SR 56 and Bruce B Downs Boulevard. He will check with Venkat to see the status of this, as they were working with both Duke Energy and Withlacoochee Electric because there are boundaries that split SR 56. Discussion followed.

Clinton Wynn (Local Resident): The recent fatality that concerned Clinton was in front of Tractor Supply with a motorcyclist. A young man was going westbound coming from Hicks Road and SR 52 towards Tractor Supply towards Chicago Avenue. He wasn't drinking or speeding. There have been a lot of fatalities from motorcycles on SR 52, SR 54, US 301, etc. SR 52 is a bad area, as from the toll road, west, it is dark all the way to Chicago Avenue. Clinton sent a letter to Tina that he provided a letter to the landowner that is just east of the Tractor Supply, that he would go by there with his tractor and cut the debris back. You cannot see around the corner due to the debris on the north side of SR 52. Clinton states that due to not being able to see, he goes through Parkwood Street to avoid pulling out on SR 52. The debris is too high up and too far out, even though it does not encroach on the sidewalk. Discussion followed.

Tina Ruso (Pasco MPO): Tina shared a fatal crash in Pasco County on SR 52. On November 2nd, 2024, at 10:25pm, vehicle one, a Mitsubishi Outlander, driven by a 51-year-old Holiday man, was traveling eastbound on SR 52. Vehicle two, a KTM motorcycle, operated by a 21-year-old New Port Richey man, was traveling westbound on SR 52. At the intersection of Parkwood Street, vehicle one turned left into the path of and was struck by vehicle two. The motorcyclist suffered fatal injures at the scene of the crash. Driver one suffered minor injuries, as did a 16-year-old male passenger and a 16-year-old female passenger. A 48-year-old female passenger suffered serious injuries. All four were transported to area hospitals for medical care. Discussion followed.

Clinton Wynn (Local Resident): The debris is on the east side of the Tractor Supply between the furniture strip plaza and Tractor Supply. The curve adds onto the line-of-sight issue. Discussion followed. Jim Reiser, LEL, suggested speed feedback signs or other traffic calming measures. Eric believes there was a safety review on SR 52. Eric will go back through the records to find it. Discussion followed. SR 52, east of Parkwood Street/Tractor Supply will be added to the problem location sheet.

Tina Russo (Pasco MPO): Discussion followed about the fatal crash on SR 54 and Grant Boulevard. The fatal crash was a freightliner propane tanker truck vs a pedestrian. Tina reached out to Andrew Gray, JMT, on this. Tina will also reach out to Jim Reiser on this on the law enforcement side of this fatal crash as well.

V. New Business

Education

Sheila Rainey (John's Hopkins All Children's Hospital): Sheila, Tina, and Casey went to Anclote Elementary School to do some bike and pedestrian safety with their kids. They were participants in the bike poster contest last year. They handed out 85 helmets for 3rd and 4th graders. They also did instruction and did a lesson for 165 kids. For Safe Kids, they had their luncheon the other day and Tina received the Pasco County Member of the Year recognition. Discussion followed.

Kasey Cursey (Pasco MPO): Kasey suggested sending out to the CTST group information from Doctor Meghan Martin talking about the top ten things that will land you in the hospital just before the season. Doctor Meghan Martin is a pediatric trauma doctor who works in the ER. Hoverboards, e-bikes, and button batteries were some of the top things that can land someone, especially a child, in the hospital. Discussion followed.

Brentin Mosher (USF CUTR): Law enforcement has started to do the teen impact safety classes. They have been to a few classes in Pinellas County. There is none currently in Pasco County.

Sheila Rainey (John's Hopkins All Children's Hospital): Battle of the Belts has transitioned over to a statewide program. The state is offering free kits to the high schools to get them started. There is a limited number of kits available. Pasco County has been a leader in doing that program. They are looking at new schools interested in Battle of the Belts. There is a count being done at the beginning without the students knowing as they're rolling into school, counting how many kids are wearing seatbelts. Then the school does a push campaign for students to hear how important seatbelts are. At the end of the week, there are counts

again to see if seat belt usage has changed. It is a fun, safety-oriented program. Discussion followed. After the hurricane, Sheila's team went on a hurricane relief effort. They have given out over 260 car seats in two months. They educate each parent, have the parent install the car seat, and then they check installation. They started this on October 3rd, which was one event prior to the second hurricane. The biggest issues were the flooding of the car seats. Discussion followed.

Enforcement

Tina Russo (Pasco MPO): There is going to be a saturation on all of US 19 on December 18th.

Engineering

Tina Russo (Pasco MPO): Paco County Engineering Services was awarded a Safe Streets grant and there was a lot of crosswalks and RRFB discussions. Pasco MPO just signed their agreement, and they are starting their task order with their safety action plan.

Crash Statistics

Lori Palaio (JMT): Lori Palaio discussed the fatal crash map. From January 1st to September 17th, 2024, there have been 74 fatal crashes. At the last CTST from January 1st to August 3rd, 2024, there were 65 fatal crashes. The nine new fatal crashes include one rollover, two bicycle, one run off road, one head one, one other, and three left turn fatal crashes. For the two new bicycle fatal crashes. The first bicycle fatal crash was on August 26th, 2024, at 10:02am (Report Number 26396193) on Chancey Road and Zephyr Preserve Place, not at the intersection, in day, clear, and dry conditions. Driver one failed to observe that non-motorist one was traveling west in the eastbound lane of Chancey Road as he was approaching other cyclists traveling west in the westbound lanes. The second bicycle fatal crash was on September 2nd, 2024, at 1:50am (Report Number 26410329) on Long Avenue and 15th Street, not at the intersection, in darklighted, clear, and dry conditions. Vehicle one was traveling westbound on Long Avenue approaching the intersection of 15th Street. Non-motorist one was traveling in the westbound lanes of Long Avenue just west of 15th Street. As the driver of vehicle one crested the hill he did not observe anyone in front of him in the roadway until last minute. The front passenger side of vehicle one collided with the rear of non-motorist one's tricycle.

There are 74 fatal crashes through September 17th, 2024. Same period in 2023 there were 63 fatal crashes. So, Pasco County is up by 11 fatal crashes same period. Note that motorcycle fatal crashes are the highest fatal crash mode of travel in Pasco County. There are currently 26 motorcycle fatal crashes.

Tina Russo (Pasco MPO): We have the 60-day lag with Signal 4. She showed the motorcycle fatalities for Pasco County up until October 10th. There have been 30 motorcycle fatal crashes. Two of them were alcohol related and 17 of the fatal crashes occurred at night. Eleven of the motorcycle fatal crashes were left turn fatal crashes. There have been nine fatal crashes since October 10th, so we are around 39 motorcycle fatalities year to date in Pasco County. A lot of aging road users make left turns in front of motorcycles. The Safety Action Plan will do a deep dive into crash data to see if they can figure out what countermeasure options that can be implemented.

VI. Calendar Updates / Activity Reports

Anthony Chaumont (JMT): Anthony presented on the FDOT Highway Safety Matrix. It is a tool that compares all the emphasis areas from the Florida Strategic Highway Safety Plan. The emphasis areas are the areas that generally represent the groupings, statistically where there are the most fatal and severe injury crashes. It is a comparative presentation of the 2024 to the new 2025 data that's available. Group one represents populations greater than 200,000. Pasco County's average rank improved, so there were less crashes (average rank from 6.4 to 7.1) between 2024 and 2025. In Pasco County aging road users went from the highest county to number two rank, so there was slight improvement in that category. Distracted driving remained the same as the number two county. Impaired driving improved quite a bit, it was the number four county and now it is ranked as number nine. Occupant protection remained the same at 12. Pedestrian and bicyclists remained the same at number eight. Speeding and aggressive improved by one category. Teen drivers remained the same from the previous year. Work zones got a little worse, as it went from number six ranking to number five ranking. Anthony provided additional statistics and distributions between the different counties. He directed everyone to the highway safety matrices on https://www.fdot.gov/Safety/grants/highwaysafetymatrices.shtm

Discussion and questions followed.

Jonathan Rose (Zephyrhills PD): There is an increase in Zephyrhills crashes because they have been educating the officers now on proper reporting of crashes, so they are documenting more of the information in the crash reports, which is why it is reflecting that increase now.

Jim Reiser (LEL): They just did training recently for crash reporting to make sure the accurate information is being captured in these reports. The DHSMV is looking to come back year and do some additional training. There was a heavy representation of D7 in that training. Hopefully the data will improve going forward as more officers learn what boxes to properly check when investigating these crashes.

Discussion and questions followed.

Lori Palaio (JMT): Hernando County applied for a bright stick request. FDOT is reviewing some of the HSIP applications currently. There is some funding available, so if anybody wants to apply, now is the time to do so.

IX. Open Forum/Announcements

Jim Reiser (LEL): Holiday Drive Sober Get Pulled Over starts on Friday and runs through January 1st. He is motivating some law enforcement to get some extra patrol over the holidays. Pasco County Sheriff's Office trained 65 deputies in the basic field sobriety classes. Discussion followed.

Tina Russo (Pasco MPO): Tina will be leaving Pasco MPO on December 27th. She is joining FDOT District 7 safety team as the new bike ped specialist. Ginger's old position has been vacant for over a year.
