Pasco CTST - July 23, 2025

Meeting started at 1:32pm

I. Welcome and Introductions were made.

II. Meeting Dedication

Christina Boulnois (Lochner): Christina discussed the focus on speeding for the month, highlighting the collaboration between FHP, FDOT, NHTSA, and FLHSMV. The aim is to keep attention on preventing fatalities and serious injury crashes. Two specific incidents were highlighted:

Little Road and San Miguel Drive (February 5th, 2025): A vehicle crash resulted in a double fatality. The southbound vehicle, traveling over 100 mph, struck a left-turning vehicle, causing it to overturn, roll over, and catch fire. The driver and passenger of the turning vehicle were pronounced dead at the scene, while the speeding driver was severely wounded.

Wesley Chapel Boulevard North of Progress Parkway (May 1st, 2025): A motorcycle crash resulted in a fatality. The motorcyclist, speeding northbound, lost control, hit the curb, collided with a street sign and light pole, and was found on the shoulder and sidewalk. The crash occurred under dry conditions, with no environmental factors contributing.

Christina emphasized that these incidents were preventable and stressed the importance of focusing on safety to avoid such tragedies.

III. Minutes Approved

June minutes were approved.

IV. Old Business

- 1. **Daughtery Road and US 301** Eric Henry, FDOT, stated that a left turn study was conducted but did not meet the warrants for a left turn phase. Further feedback and potential alternative approaches are being considered.
- 2. SR 52 from east of Colony Road to Moon Lake Road Eric stated that an ICE study is ongoing, and findings will be shared once completed.
- SR 56 from Meadow Point Boulevard to US 301 The lighting issue is still under review, with a coordination meeting planned between the County and FDOT.

Christina Boulnois (Lochner): Christina provided an update on the Innovate Pasco 2050 study, focusing on safety analysis and identifying high injury network hotspots throughout the county. The study highlighted various hotspots across the county, particularly focusing on major roadways such as US 19, State Road 54, and State Road 56. Between 2019 and 2023, there were over 1,500 bicycle and pedestrian crashes and 472 fatalities. Christina emphasized the importance of evaluating high injury network corridors and intersections. The top 10 high injury network corridors were identified using data from Signal 4 Analytics. One of the highlighted corridors was Little Road from State Road 52 to Fivay Road, which had 158 crashes,

two fatalities, and six serious injuries. The safety score for this intersection was calculated based on the highest level of injury sustained in each crash and the travel mode of victims. Specific intersections discussed included:

State Road 52 at Little Road: This busy intersection had 158 crashes, two fatalities, and 61 injury crashes over a five-year period.

Ridge Road at Little Road: Another significant intersection with 329 crashes, one fatality, and several serious injuries.

Christina proposed conducting mini Roadway Safety Audits (RSA) to evaluate these intersections and corridors. The goal is to incorporate safety measures based on crash volumes, types, and severity. She emphasized the importance of a collaborative approach, involving engineering, education, EMS, and law enforcement to gain different perspectives and address safety issues effectively. Jim Hartwell, Element Engineering Group, inquired about the data collection process for intersections and the specifics of fatal crashes. Christina explained that the data was pulled to the end of the turn lanes for the influence area, typically around 250 feet, and that the fatality data was accurately shown on Signal 4. This comprehensive approach aims to improve road safety by identifying high-risk areas and implementing targeted safety measures through collaborative efforts.

Jeffrey Moncalian (Pasco County): Jeffrey provided an update on the ongoing route study and safety analysis for Little Road and Ridge Road. The analysis includes evaluating access points into businesses, timing and movements at intersections, and conducting signal warrants at specific locations. Jeffrey mentioned that the goal is to improve intersection operations and safety within this area. The study will involve collecting traffic counts, crash data analysis, and near-miss analysis to develop a comprehensive safety plan. Christina acknowledged the efforts and suggested modifying the evaluation list to avoid duplicating efforts. Jeffrey also highlighted specific issues at Little Road and Fivay Road, where flashing yellow restrictions have been implemented to reduce crashes. Additionally, the main issue from Fivay Road to State Road 52 involves the first median opening near ALDI, which they plan to channelize to reduce incidents. Christina proposed pulling crash data to identify other areas of concentration and suggested focusing efforts on the intersections not currently under assessment. The group agreed to participate in reviewing the crash data for future meetings, with a collaborative approach involving education and enforcement.

V. New Business

Education

Eric Henry (FDOT): On August 1st, FDOT will be at the One Stop Shop in Dade City for a back-to-school event, where they will distribute reflective vests, workbooks, bike lights, and other materials. Additionally, they will be filming a PSA at Pasco Safety Town with the Tampa Bay Rays mascots to promote stopping for school buses and children crossing in the crosswalk.

Izzy Discepolo (Bayonet Point Hospital Trauma Center): Izzy mentioned picking up back-to-school safety bike and pedestrian information from Tina at Safety Town for hospital donations. Izzy plans to distribute these materials to various hospitals, including Oak Hill, to include them in their donation piles. Eric encouraged spreading the materials to any interested parties and mentioned having a large supply of workbooks targeted at younger kids for safe walking and biking.

Renisa Martinez (John's Hopkins): They recently distributed safety materials to 450 elementary school teachers, including car seat safety, bike and pedestrian safety, and pool safety brochures. These materials also included a QR code linking to a YouTube video. Renisa mentioned an upcoming event on August 9th, a back-to-school bash at Wesley Chapel District Park. The event will feature food trucks, bounce houses, and various vendors. She expressed interest in collaborating with Eric Henry to obtain additional safety materials for distribution at the event. Additionally, Renisa highlighted a change at the Bike Ped Resource Center, where each person is now limited to ordering 100 helmets per fiscal year. This change is not limited per agency, so multiple certified individuals from the same agency can each order 100 helmets. She suggested that this might encourage more people to get certified and mentioned plans to create a flyer to update all partners about this change.

Brentin Mosher (CUTR): Brentin shared an update on an upcoming educational initiative. They are working on a proposal for Eric Henry to conduct educational outreach at the new midblock pedestrian crosswalks on US 19, specifically at San Marco Drive and between Elizabeth Avenue and Edna Avenue. The plan involves on-the-street education, distributing backpacks and bike lights, and possibly using mailers or geofencing, depending on what is appropriate for the corridor. When asked about the timing, Brentin mentioned that they would be working on it within the next month, although the details have not been finalized yet.

Enforcement

Bruce Wiener (Pasco County Sheriff's Office School Crossing Guard Unit): Bruce Wiener provided an update on the Pasco County Sheriff's Office School Crossing Guard Program. A new K-8 school, Skybrooke, is opening, and the program is prepared to support it. The program won the Program of the Year award from FDOT, recognizing it as the best in the state of Florida. The program currently has 138 school crossing guards serving 31 schools with 117 posts. They receive numerous applications weekly. The crossing guards' range in age from 27 to 94 years. Due to a shortage of deputies, the program handles speeding issues independently. They use safety cones to slow down traffic and direct traffic themselves. If necessary, they report troublemakers to law enforcement. Training sessions are scheduled for the first week of August at Safety Town. The training includes de-escalation techniques and is open to other police departments. The program uses lawn signs for recruitment, which has been highly effective, with 96 percent of interviewees mentioning they saw the sign. Bruce and his team provided training to the Florida State Guard on traffic control and command at gas stations after hurricanes. Bruce emphasized the program's high standards and commitment to safety, highlighting their proactive approach to managing traffic and ensuring the safety of children. Wayne Gaskill raised concern about the issue of speeding and inquired if there were any plans to hire more patrol officers to address the problem. Bruce Wiener responded by explaining that the days of a dedicated traffic unit are largely over due to the high volume of

calls that deputies handle daily, including serious crimes. Deputies are trained in traffic enforcement, but they often lack the time to focus on it due to other pressing duties. Bruce mentioned that deputies are instructed to make traffic stops when they have a moment, such as while typing reports at a stop sign or traffic light. However, he acknowledged that this is not a comprehensive solution and that the situation is unlikely to improve soon without additional manpower and funding. Wayne expressed his concern about the high death toll from traffic incidents in Pasco County, noting that there were 450 fatalities in the last four years. Bruce agreed that the issue requires more resources and emphasized that the problem extends beyond the committee's scope, requiring higher-level intervention and funding. Eric Henry then asked about the yard signs used for recruiting school crossing guards, which had been highly effective. Bruce explained that the signs were introduced after a change in school times led to a shortage of crossing guards. The signs have been successful in attracting applicants, with 96 percent of interviewees mentioning they saw the sign.



Engineering

Crash Statistics

Lori Palaio (JMT): From January 1st through May 2nd, 2025, there were 27 fatal crashes. At the last CTST from January 1st through April 15th, 2025, there were 24 fatal crashes. The three new fatal crashes were all run off the road fatal crashes.

Report Number 26970273: This run off the road fatal crash occurred on April 13th, 2025, at approximately 1:50am, on I-75 and SR 52, not at the intersection, in dark-lighted, clear, and dry conditions. The vehicle was traveling southbound in the center lane of I-75, just south of SR 52. The vehicle was approaching another vehicle. The driver swerved to the left to avoid a collision with another vehicle.

Report Number 26971056: This run off the road fatal crash occurred on April 13th, 2025, at approximately 9:10am, on Pasco Road and SR 52, not at the intersection, in day, clear, and dry conditions. This was a fatal motorcycle crash. The motorcyclist was traveling north on Pasco Road, north of SR 52. The motorcyclist failed to negotiate a left curve and as a result collided with the curb.

Report Number 26981798: This run off the road fatal crash occurred on May 1st, 2025, at approximately 12:25 pm, on Wesley Chapel Boulevard and Progress Parkway, not at the intersection, in day, cloudy, and dry conditions. This was a fatal motorcycle crash. The motorcyclist was traveling north in the outside lane of Wesley Chapel Boulevard at a high rate of speed, approaching Progress Parkway. The motorcyclist lost control, causing the motorcycle to veer onto the right shoulder.

There are currently 27 fatal crashes through May 2nd, 2025. Same period in 2024 there were 34 fatal crashes. So, we are down by seven fatal crashes in the same period. Approximately 59.3 percent of the fatal crashes in Pasco are occurring at night.

VII. Highway Safety Improvement Program (HSIP) Updates

Eric Henry (FDOT): Eric Henry provided an update on a pending request from the city of New Port Richey in Pasco County. The request involves the installation of two Rectangular Rapid Flashing Beacons (RRFBs) on Main Street and Van Buren Street. The team is currently reviewing this request and working on getting the RRFBs purchased. Eric also encouraged attendees to reach out to him or Lori Palaio if they have any other projects in mind or if they are considering applications for the Highway Safety Improvement Program (HSIP). He offered to discuss potential projects and provide guidance, even if attendees are unsure about their ideas.

VIII. Open Forum/Announcements

Amy Elmore (EXP): Amy Elmore mentioned that she had a presentation ready and sought input from Eric Henry on whether to proceed with it or move it to the next meeting due to time constraints. Eric suggested postponing the presentation to the next meeting to allow for a more thorough discussion.

Brian Michaels (Pasco MPO BPAC): Brian Michaels also had a presentation planned for Pedestrian Safety Month in October, highlighting best practices and exciting news from last year. He noted that the program's cost was zero, utilizing digital media and message board signage. Eric agreed that both presentations should be scheduled for the August meeting to ensure ample time for discussion.
