#### Pasco CTST - August 27, 2025

Meeting started at 1:34pm

I. Welcome and Introductions were made.

#### II. Meeting Dedication

Christina Boulnois (Lochner): Christina presented the meeting dedication for this month's meeting. This month is child safety awareness month. The Florida Department of Highway Safety and Motor Vehicles. along with FDOT, FHP, and several other safety partners, are working together to educate and raise awareness of how everyone can help children have a safe start this school year. That includes school bus and school zone safety, crosswalk safety, seat belt and child restraint safety, etc. The meeting was dedicated to a fatal crash on December 12th, 2024. The fatal crash was a vehicle crash which resulted in a teen driver fatality along US 41 at a private road, 100 feet north of Little Lake Road. The driver was 17 years old and did not wear a seatbelt. The vehicle was traveling southbound on US 41, a two-lane road, away from the intersection of Little Lake Road. A northbound car crossed the dashed centerline, attempting to overtake traffic. Vehicle one swerved into the ditch to avoid a head-on collision and struck a concrete culvert. Christina discussed that the ELEE program has included Pasco County in initiatives to improve road safety through increased law enforcement presence and public awareness campaigns, focusing on high-crash corridors like US 19 and areas with specific safety issues such as speeding, aggressive, and distracted driving. Recent ELEE efforts in June 2025 involved numerous law enforcement agencies, including those from Pasco County, on US 19 and have resulted in traffic stops, citations, and the recovery of a stolen vehicle demonstrating the program's impact. The program also includes educational outreach to schools, with first responders and public educations from Pasco County involved in initiatives like "Prom Promise" and "Back to School" to promote safe driving among youth.

Brentin Mosher (CUTR): Brentin discussed what ELEE is. Law enforcement offers conduct traffic enforcement on state roadways. The man-hours turn into points for equipment and can receive speed trailers, vests, stylus, cones, variable message signs, etc.

Isabella Discepolo (HCA Florida Bayonet Point Hospital): Isabella discussed Battle of the Belts with Safe Kids. Anclote had the most amount of seatbelt uses in 2025. Discussion followed.

David Cruz (AARP): David Cruz discussed the issues with not having hands free driving. He stated that in his courses he teaches he explains "two seconds too close," meaning, if you are within two seconds from a vehicle, you are at risk of being in a car crash.

- 1. Daughtery Road and US 301 Eric Henry, FDOT, will follow up on this. Jonathan Rose from Zephyrhills PD, stated that this road is an ongoing issue. Jonathan Rose stated that we can pull the crash data when it is snowbird peak season, around January or February.

#### V. New Business

#### Education

Brentin Mosher (CUTR): There will be education on the midblock crosswalks on US 19 at San Marco Drive, and US 19 at Elizabeth Avenue. There will be geofencing, as well as a mailer, as well as other educational efforts. Brentin explained to the group with a midblock pedestrian signal is.

Isabella Discepolo (Bayonet Point Hospital Trauma Center): Isabella mentioned that on August 9<sup>th</sup>, there will be an Always Stop on Red event. Tina is talking to hospitals on moving around safely.

Enforcement

#### Engineering

David Cruz (AARP): David discussed his concern on Stone Road between Regency Park Boulevard and US 19. There is a senior citizen community, and it is a blind intersection. There is a fire hydrant on the southwest corner and the grass is typically long. David wants a stop sign at this location. He has forwarded this request to the county, previously, and there has been no progress. David is hoping for assistance on this.

#### Crash Statistics

Lori Palaio (JMT): From January 1st through June 4th, 2025, there were 36 fatal crashes. At the last CTST from January 1st to May 2nd, 2025, there were 27 fatal crashes. There were nine new fatal crashes, which included two run off the road, two rollover, one sideswipe, one head on, one left turn, one rear end, and one pedestrian fatal crash (coded as a bicycle fatal crash on the fatal crash map). For the new pedestrian fatal crash, it occurred on May 15th, 2025, at 5:02 AM (Report Number 26987302) on State Road 54 and Collier Parkway, not at the intersection in dark-not lighted, clear, and dry conditions. The pedestrian was running along the roadway and entered the direct path of vehicle one. Left turn fatal crashes were the highest fatal crash type with 25.0%, followed by off road fatal crashes with 19.4%, and head on fatal crashes with 13.9%. There are currently 36 fatal crashes through June 4th, 2025. Same period in 2024 there were 48

fatal crashes. Pasco County is down by 12 fatal crashes in the same period. Lori discussed that there have been a lot of motorcycle fatal crashes in Pasco County.

Jonathan Rose (Zephyrhills PD): Jonathan Rose mentioned that there were two motorcycle fatalities in July. He also discussed that Zephyrhills PD is doing DUI saturations. There was a drug DUI last night. Jonathan is waiting for the statistics from the saturation.

#### VI. Calendar Updates / Activity Reports

Lori Palaio (JMT): Lori discussed the Showcase Your Impact, Get Recognized by ITE opportunity. October is Community Planning Month and Pedestrian Safety Month. Submit Your Projects to ITE by August 29<sup>th</sup> for a chance to be featured across platforms and publications. ITE is calling on public agency members to share standout projects that demonstrate the power of transportation planning and innovative efforts to enhance pedestrian safety. Eligible projects must have been completed within the past five years. You should include a short project description (150 words or fewer), photos or visuals, and names of team members or partners involved. This is due this Friday, so if anybody has any project ideas that represent the power of transportation planning to enhance pedestrian safety, please apply.

Brentin Mosher (CUTR) provided details about a press conference, noting that a mother from USF whose son was involved in an e-scooter crash will be present.

#### VII. Highway Safety Improvement Program (HSIP) Updates

Lori Palaio (JMT): Lori discussed that HSIP funding is available and to apply for low-cost safety materials on local roadways. FDOT will purchase the materials, but the local agency must install and maintain it.

#### VIII. Open Forum/Announcements

Discussion followed on Florida Impact Teen Driver, which is an organization intended to help teens reduce their risk of being involved in auto collisions, particularly those caused by everyday distractions and inexperienced decision making.

David Cruz (AARP): David Cruz discussed that there is an app called PulsePoint. The PulsePoint app is a mobile application suite, primarily known for PulsePoint Respond, which alerts CPR-trained individuals to nearby cardiac emergencies in public places, simultaneously providing nearby Automated External Defibrillator (AED) locations to help increase survival rates. The foundation also offers PulsePoint AED, a tool for citizens to identify and add AED locations to a community registry, which dispatchers can then access during a cardiac event. David mentions that notifications are sent within 300 feet of a cardiac event.

Angel Avila (Pasco MPO): There will be a safety action plan meeting on October 9<sup>th</sup> at Starkey Ranch. There will be a task force meeting on September 23<sup>rd</sup> at the City Council in Zephyrhills, where they will discuss project prioritization.

Ariana Roman (MADD): Ariana introduced herself from MADD to the CTST group. She works with Jeannine Laurence. Ariana will be presenting at Wiregrass High School and then future schools.

Brian Michaels (Pasco MPO BPAC): Brian presented the project red light update. Stop law 316.130 was changed on August 1st, 2008, which requires all motor vehicles to stop and remain stopped at all signalized intersections. The purpose of the update was to bring driver awareness to sign changes throughout FDOT District 7 and the tri county Tampa Bay area at signalized intersections with a target date of October 1st, 2025, during pedestrian safety month. Goals include promoting the newer R10-15a Stop for Pedestrians through driver education, utilizing all-media, utilizing electronic message boards with stop for pedestrian message, engaging all law enforcement local county and state to issue warnings or tickets, etc. In 2024, Pasco County Utilities sent out 275,000 newsletters, Pasco County tax collectors had five offices paying safety slides that reached over 60,000 people, in 2024 Pasco County estimated that over 350,000 people saw the message to stop for pedestrians, etc. For 2025, Pasco Health Department will play safety slides, there will be DMS message boards for stop for pedestrians, etc. Discussion followed.
